# a Neighbourhood Police Crime and Traffic:

- i 27/09/2023 recently-installed 20mph road sign uprooted and removed on Grange Road which was subsequently re-installed, and is now 'leaning'. PCSO Jones confirmed that a CCTV on a neighbouring property could be utilised for purposes of observation so long as a 'CCTV in operation' sign is displayed. 20/10/2023 Report of motorcyclist coming off his motorbike after hitting mud on Itton Road at Howick; rider sustained bruising and minor injuries.
- ii Chair asked if future Neighbourhood Police reports could include a wider area of the Wye Valley.
- iii PCSO Jones confirmed that the updated staffing list of the local police team could be circulated amongst the community.
